### How to Leave a Legacy to Oxford Playhouse

Arranging to leave a legacy to Oxford Playhouse gives you the satisfaction of supporting its immense and wide-ranging contribution to the Arts. The Playhouse's charitable status may also offer you the opportunity to reduce the tax due on your estate. These benefits vary internationally, and your financial advisor is best placed to advise you.

Listed below you will find the most common types of legacy where you can support the Playhouse as a whole or some aspect of our work with which you have the greatest affinity.

#### A residuary gift:

This is the gift of all or part of the value of your estate, after debts, other legacies and liabilities have been met. This has the advantage of automatically keeping up with inflation.

The suggested wording for a residuary gift is:

"I give all (or specify a %) of the residue of my estate to The Oxford Playhouse Trust (registered Charity No. 900039) of Beaumont Street, Oxford OX1 2LW for its general charitable purposes. I further direct that the receipt of the Chief Executive, or other duly appointed officer for the time being of the said charity, shall be sufficient discharge for my Executors or Trustee."

#### A monetary legacy:

You can also choose to leave a sum of money, also known as a pecuniary gift, which you can arrange to be increased in line with inflation.

The suggested wording for this form of legacy is:

"I give the sum of .... pounds (or a description of a specific asset) to The Oxford Playhouse Trust (registered Charity No. 900039) of Beaumont Street, Oxford OXI 2LW for its general charitable purposes. I further direct that the receipt of the Chief Executive, or other duly appointed officer for the time being of the said charity, shall be sufficient discharge for my Executors or Trustee."

### How to Leave a Legacy to Oxford Playhouse

#### A specific legacy or gift in kind:

This is the gift of something valuable like a property, a piece of jewellery or stocks and shares. The form of wording is the same as a pecuniary gift, except that the gift is specified instead of a cash sum. It would be very helpful if you could let us know if you would like to leave any specific items to the Oxford Playhouse so that we can ensure that we are able to accept the items and will be able to use them as you wish.

#### A reversionary legacy:

This gift has the advantage of providing for your family first and then benefiting the theatre. So when the original beneficiary dies, the gift in your will reverts to The Oxford Playhouse Trust. Your solicitor or legal advisor will be able to provide you with wording for this form of legacy.
